

Family LegaciesTM biography is a "Tribute to a life lived", which includes photos and words that can be viewed at the cemetery or on our website at www.familylegacies.com. This unique biography can assist in the healing process and gives the family a central location to store family history. There is no additional charge for this service.

The Family Service Advisor meets with the family and presents the Family LegacyTM program. All families receive a packet to fill out and return along with pictures to be scanned by a Family Service Advisor. The packet is sent to the Family Legacies Administrator who is located at the Buchanan Group office for processing, where the legacy is created for the website. After updates are completed the family can be contacted to view the legacy.

Family LegaciesTM Introduction

Family LegaciesTM is a new and exciting technology that was designed exclusively for the many families that we serve.

Family Legacies[™] will be a treasured pictorial tribute for your loved ones, which includes a tribute, photo scrapbook, family tree and property location.

The legacy you are about to create can be viewed at the cemetery or online at www. familylegacies.com. There are three steps involved in creating a legacy; general information, family information and photo scrapbook.

In Step One you will be asked to fill out general information such as your name, relationship to the deceased, phone and e-mail, family service advisor's name plus his or her phone and e-mail. For the first step in the Family Legacies process, you will be asked to provide information, provide one photo of your loved one, and write a short tribute (500 words or less) to that person.

In Step Two Family LegaciesTM has a built-in Family Tree feature that provides genealogy information that will be appreciated by family and friends for years to come. You will be asked to fill out information about spouse's, marriage dates, parents, step-parents, siblings, children and great grandchildren.

The legacy also contains a photo scrapbook where up to 12 photos and/or any other item can be scanned would become a part of this personalized memorial. In "Step Three", photos or other items (e.g. Birth certificates, special keep sakes, and drawings) for the scrapbook are gathered. You can select any photo under Photo Scrapbook to view a larger photo and caption.

Property location is available by selecting Location Map.

A legacy is a living form of history. You can add or subtract information at anytime. You can also complete in stages or all at once.
